INVITATION TO BID

 The PHILIPPINE TEXTILE RESEARCH INSTITUTE (PTRI), through the GAA-Locally Funded Project "Enhancing the Product of Abaca (Musa textilis) and Other Natural Fibers Pretreatment via Wet on Wet Processing" intends to apply the sum of THREE MILLION PESOS (Php3,000,000.00) being the total Approved Budget for the Contract (ABC) for payments of One (1) Lot Laboratory Roving Machine inclusive of taxes, fees, delivery costs and other incidental charges.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PTRI, now invites bids for the "Procurement of the above equipment with <u>90 Calendar Days</u> delivery period. Bidders should have completed, within five (5) years from the date and submission and receipt of bids, a contract similar to the Project as provided for in Section 23.4.1.3 (a) and (b) of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act" (Handbook on Phil .Government Procurement, 8th Edition, 2016).
