INVITATION TO BID FOR the following:

1. One(1) Lot Shotcrete Machine;

- 2. One (1) Lot Compression Molding Press; and
- 3. One (1) Lot Laboratory Yarn Singeing Machine.
- 1. The **PHILIPPINE TEXTILE RESEARCH INSTITUTE (PTRI),** through the CY 2021 DOST-GIA Projects intends to apply the sum of TEN MILLION FOUR HUNDREDTHOUSAND PESOS (Php10,400,000.00) being the ABC to payments under the contract for each of the following items:

Bids received in excess of the ABC for each item shall be automatically rejected at bid opening.

- The *PTRI* now invites bids for the above Procurement Project. Delivery of the Goods is required by 60 Calendar Days (Item 1); 90 Calendar Days (Item 2); and 120 Calendar Days (Item 3). Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from *PTRI through the BAC Secretariat* and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on 11 August 2021 to 30 August 2021, from the given address and website(s) below upon payment of One Thousand Five Hundred Pesos (Php1,500.00) for Item 1; Five Thousand Pesos (Php5,000.00) for Item 2; and Three Thousand Nine Hundred Pesos (Php3,900.00) for Item 3. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The *PTRI* will hold a Pre-Bid Conference¹ on *18 August 2021* at 9:00 a.m. (Item 1); 10:00 a.m. (Item 2); and 11:00 a.m. (Item 3) through video conferencing or webcasting *via Google Meet*, which shall be open to prospective bidders. Link will be shared to all prospective bidders at least one hour before the conduct of Pre-Bid Conference.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before 30 August 2021 from 8:00 a.m.to 9:00 a.m. (Item 1); 9:00 a.m. to 10:00 a.m. (Item 2); and from 10:00 a.m. to 11:00 a.m. (Item 3). Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on 30 August 2021 at 9:00 a.m. (Item 1); 10:00 a.m. (Item 2); and 11:00 a.m. (Item 3) at the PTRI Training Room, PTRI Main Building, General Santos Avenue, Bicutan, Taguig City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The bidders shall submit three (3) sets of documents. Original, Copy 1 and Copy 2, duly sealed, labeled and counter signed. Each set contains two (2) envelops, one (1) Technical and one (1) Financial Proposal. The three (3) sets 1.e, Original, Copy 1 and Copy 2, must be contained in an outer envelope/packaging duly sealed, labeled and counter-signed. The labels must contain the PhilGEPS reference number.

- 11. The PTRI reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
