BAC RESOLUTION RECOMMENDING NEGOTIATED PROCUREMENT SEC. 53.9 SMALL VALUE PROCUREMENT AS THE METHOD OF PROCUREMENT FOR THE PROJECT

"RFQ No. 2440-24 1 lot Fabrication Service for Modified Bamboo Cleaving Machine"

WHEREAS, the **PHILIPPINE TEXTILE RESEARCH INSTITUTE (PTRI)** requisitioned **RFQ No. 2440-24 1 lot Fabrication Service for Modified Bamboo Cleaving Machine** charged to DOST-GIA "Field Verification of bamboo textile fiber technology using Giant bamboo (*Dendrocalamus asper*) in Northern Mindanao- Y2", herein referred to as the "Project", with a total Approved Budget for the Contract (ABC) of **Three Hundred Forty Thousand Pesos (Php340,000.00)**;

WHEREAS, said requisition is included in the 2024 Annual Procurement Plan of the Institute;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Negotiated Procurement-Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted in the PhilGEPS website for three (3) days, starting on 13 November 2024 to 18 November 2024;

WHEREAS, PTRI sent the RFQs/RFPs to three (3) service providers, suppliers or contractors of known qualifications, namely: (1) Gecar Machine Solutions Inc., (2) EA Rañola Machine Shop, Inc., and (3) Jasmedin Technology Incorporated, of which two (2) suppliers responded to the PhilGEPS posting and email, and submitted their offer;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(ii) of Annex "H" of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, those who responded through any of the required postings shall be allowed to participate and receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

WHEREAS, the detailed examination and evaluation of offers received thru email per Abstract of Canvass No. 24-966 dated November 18, 2024 resulted in the following:




