

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION No. PB16- 2024

WHEREAS, the **PHILIPPINE TEXTILE RESEARCH INSTITUTE (PTRI)** advertised the Invitation to Bid for the Procurement of **One (1) Lot Bamboo Slatting Machine**, with an Approved Budget for the Contract of Php 1,200,000.00 charged to CY 2024 GIA Project "Community-based Verification of Fiber Extraction Technology using Local Bamboo Species as a Textile Material", in the PhilGEPS and DOST-PTRI websites, and posted in a conspicuous place at the premises of PTRI, continuously for seven (7) days;

WHEREAS, in response to the said advertisement and posting, two (2) bidders expressed Interest and purchased the bid documents;

WHEREAS, two (2) bids were received before the bid opening on 23 July 2024, 10:00 AM, from Gecar Machine Solutions, Inc. and Analytical and Sample Prep Machines, Inc., of which both bidders passed the preliminary examination of bid;

WHEREAS, upon detailed evaluation of the technical specifications offered by Analytical and Sample Prep Machines, Inc. it was found that the it did not comply with the following specifications indicated on the table below:

WHEREAS, after passing the reglementary period on the filing of the Motion for Reconsideration, the BAC proceeded with evaluation of the next complying bidder;

WHEREAS, upon evaluation of the technical specifications offered by Gecar Machine Solutions, Inc. the bidder satisfactorily complies with all of the stipulated requirements for the technical specifications.

WHEREAS, the detailed evaluation of bid conducted resulted in the following:

- b) To recommend for approval by the PTRI Director the foregoing findings.


