

**BAC RESOLUTION RECOMMENDING NEGOTIATED PROCUREMENT SEC. 53.9 SMALL VALUE
PROCUREMENT AS THE METHOD OF PROCUREMENT FOR THE PROJECT**

"RFQ No. 2679-24R 1 lot Desiccators"

WHEREAS, the **PHILIPPINE TEXTILE RESEARCH INSTITUTE (PTRI)** requisitioned **RFQ No. 2679-24R 1 lot Desiccators** charged to DOST-GIA: "Smarter OneLab for Industry 4.0 through Testing and Calibration, Education, and Discovery (OneLab for TED)", herein referred to as the "Project", with a total Approved Budget for the Contract (ABC) of **Two Hundred Thousand Pesos (Php200,000.00)**;

WHEREAS, said requisition is included in the 2024 Annual Procurement Plan of the Institute;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Negotiated Procurement-Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted in the PhilGEPS website for three (3) days, starting on 12 December 2024 to 16 December 2024;

WHEREAS, PTRI sent the RFQs/RFPs to three (3) service providers, suppliers or contractors of known qualifications, namely: (1) Chemoscience Phils. Inc., (2) LB2 Laboratory Supplies, (3) Kabers Trading, of which one (1) contractors/suppliers responded to the PhilGEPS posting and email, and submitted their offer;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(ii) of Annex "H" of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, those who responded through any of the required postings shall be allowed to participate and receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, the detailed examination and evaluation of offers received thru email per Abstract of Canvass No. 24-1038 dated December 17, 2024 resulted in the following:




